As per Decree of the Cabinet of Ministers of the Republic of Uzbekistan No. 87 dated **March 28, 2012** “On improving the structure of the Lawyers’ Training Center under the Ministry of Justice of the Republic of Uzbekistan”, the Department of international cooperation was established as part of the Center.

The Department carries out its activities on the basis of the following **regulatory acts**:



Decree of the President of the Republic of Uzbekistan “On measures to improve the procedure for the officials travelling abroad” No. PP-2142 dated March 5, 2014;



Decree of the President of the Republic of Uzbekistan “On measures to further increase the personal responsibility of officials for the effectiveness of business trips and organization of visits of foreign delegations to the Republic of Uzbekistan” No. PP-3170 dated August 3, 2017;



Resolution of the President of the Republic Of Uzbekistan “On organizational measures to further improve the activities of the Ministry of Justice of the Republic of Uzbekistan” No. RP-3666 dated April 13, 2018;



Decree of the President of the Republic of Uzbekistan “On approval of the concept for the development of the higher education system of the Republic of Uzbekistan until 2030” No. UP-5847 dated October 8, 2019;



Order of the Minister of Justice of the Republic of Uzbekistan “On measures to streamline the activities of the Ministry of Justice of the Republic of Uzbekistan in the sphere of international legal cooperation” No. 149-um dated August 29, 2020

International cooperation is carried out in **two directions**:

cooperation with specialized foreign educational institutions offering training and continuing education to legal professionals



cooperation with international organizations

Over the past 3 years, the Center has established cooperation with **analogous educational institutions** in a number of foreign countries, including:


Cooperation Agreement was signed with the Institute for retraining and qualification upgrading of judges, prosecutors and legal professionals at the Belarusian state university in 2020

Memorandum of Cooperation was signed with the Academy of Justice under the Supreme Court of the Republic of Kazakhstan in 2018

Cooperation Program was signed with the Research and Training Institute of the Ministry of Justice of Japan via videoconferencing in 2021

Signing of Memorandum of Cooperation with the Academy of Justice of the Ministry of Justice of the Republic of Azerbaijan is expected soon

Signing of Memorandum of Cooperation with the Justice Academy of the Ministry of Justice of the Republic of Turkey is expected soon





The Center carries out international cooperation in the following areas:

- organization of study visits to foreign educational institutions for the teaching staff and trainees of the Center;
- development and implementation of joint training programs;
- engaging renowned scholars, lecturers and experts from foreign educational institutions to deliver lectures at the Center;
- exchange of academic articles and publications;
- organization of conferences, videoconferences, symposiums, round tables, discussions featuring qualified national and foreign experts;
- exchange of experience in the sphere of distance education;
- coordination of activities of all faculties and departments of the Center in terms of hosting events related to the visit of guests and delegations from abroad and representatives of international organizations.

The Center has established cooperation with representative offices of many **international organizations** in Uzbekistan, in particular:

OSCE Project coordinator in Uzbekistan (OSCE) (100,000 Euro worth project is in place)



United States Agency for International Development (USAID) Legal Reform in Uzbekistan Program (technical support has been rendered to the Center as well as equipment for a training courtroom at the Center has been provided)



United Nations Development Program (UNDP) (long-term plans for the provision of public services in the framework of the project have been discussed)



German Society for International Cooperation (GIZ) Representative office in Uzbekistan, “Promotion of Legal Statehood in Central Asia” Regional Program (Agreement signed between the Minister of Justice and the GIZ office in Uzbekistan)



International NGO “Regional Dialogue” (Memorandum of Cooperation was signed in 2013)



European Bank for Reconstruction and Development (EBRD) (220,000 Euro worth project has been approved)



Konrad Adenauer Foundation Representative office in Uzbekistan (Memorandum of Cooperation signed in 2022)




In recent years (2020-2022), 10 people from among the teaching staff and employees of the Center were sent on **9 business trips abroad**, including the following cities:
